Boards, Commissions can hold "e-meetings"

The General Assembly approved on Tuesday Governor Northam's budget amendments which temporarily expands the authority for local governing bodies, planning commissions, local/regional boards and commissions, and common interest community associations to meet electronically for a broader scope of reasons.

This gives these entities the authority to meet electronically to discuss land-use applications and other development/construction-related applications during the current State of Emergency. The HBACV, HBAV and other stakeholders advocated for these amendments to ensure that local governments may resume their customary business during the State of Emergency. Intended to expand the authority for local governing bodies and

appointed commissions to meet electronically to review/take action on land-use applications (and other matters), it still remains to be seen how each local governing body and local government attorneys interpret and implement the new statute.

The HBACV is contacting local jurisdictions to determine how local boards will use this expanded meeting option. If you have projects that will be going before local planning commissions and boards, please contact them to insure you are informed of these meetings and can opt to participate.

Land-use / constructions applications are considered to be "addressing the emergency" given that delay of those applications would worsen the negative economic impacts of the pandemic.

Building Permits, Inspections office new schedules

- **1. Bedford County** Building Inspections and Permitting office is closed to the public. The department will conduct field inspections and permitting can be done online. Staff will be available to receive phone calls (540) 586-7616. The office will consider approving work through pictures, third party or written notices. These will be done on a case by case basis. - **2. City of Lynchburg** Building Inspections and Permitting office (455-3910) has closed to the general public. Please call ahead (445-3910) for information about access, permitting and inspections. Forms are available online. - **3. Amherst County** Building Inspections and Permitting office is closed to the public. The department will continue to conduct field inspections and limited permitting can be done with forms found online. Staff will be available to return phone messages. Expect a 30-minute to 60-minute delay in returned call. Please call 946-9302. Please state the reason for the call. If requesting an inspection please provide the permit number and how soon you are seeking the inspection. - **4. Campbell County** Building Inspections and Permitting office is closed to the public. Builders and others requesting permits are asked to call (434) 332-9596. The office will then provide an access to the online portal and walk you through the process. No changes yet to statewide stay at some order

Governor Ralph Northam' statewide Stay at Home order to protect the health and safety of Virginians and mitigate the spread of the novel coronavirus, or COVID-19 remains in place until June 10. However amendments are being considered to open some additional businesses. Thus far the impact of the order

For HBACV Members involved in the construction and housing industry this order will have limited impact - If you are already following the safe distancing; 10-or less employees/patrons gathered (five is preferred) and crew transport requirements. This new order strongly urges that you and your business limit travel and transportation to essential needs and maintain OSHA and State guidelines for a safe and COVID-free workplace.

has effectively reduced the overall spread of the coronavirus in the Commonwealth. Virginia had 10,998 COVID-19 cases, 372 deaths as of Thursday.

The order directs all Virginians to stay home except for allowable travel, including to seek medical attention, work, care for family or household members, obtain goods and services like groceries, prescriptions, and others as outlined in Executive Order Fifty-Three, and engage in outdoor activities while follow strict social distancing (six-feet minimum) requirements.

The order has impacted unemployment and as of Thursday 84,000 Virginians had applied for unemployment benefits.

At the time of the order, Northam said, "We are in a public health crisis, and we need everyone to take this seriously and act responsibly. Our message to Virginians is clear: stay home. We know this virus spreads primarily through human-to-human

contact, and that's why it's so important that people follow this order and practice social distancing. I'm deeply grateful to everyone for their cooperation during this unprecedented and difficult time."

BUILDER CONFIDENCE PLUNGES 42 POINTS OVER PANDEMIC

Reflecting the growing effects of the COVID-19 pandemic, builder confidence in the market for newly-built single-family homes plunged 42 points in April to 30, according to the latest NAHB/Wells Fargo Housing Market Index The decline was the largest single monthly change in the history of the index and marks the lowest builder confidence reading since June 2012. It is also the first time that builder confidence has been in negative territory (below 50) since June 2014.

"This unprecedented drop in builder confidence is due exclusively to the coronavirus outbreak across the nation, as unemployment has skyrocketed and gaps in the supply chain have hampered construction activities," said NAHB Chairman Dean Mon.

"Meanwhile, there continues to be some confusion over builder eligibility for the Paycheck Protection Program, as some builders have successfully submitted loan applications while others have not been able to. NAHB is working with the White House, Treasury and Congress to get the broadest builder participation possible. New legisation providing additional funding is expected to pass and be signed into law before week's end.

Home building remains an essential business throughout most of the nation, and by summer buyers should return to the marketplace."

"In January and February new home sales (were) at their highest pace since the Great Recession," said NAHB Chief Economist Robert Dietz. "To show how hard and fast this outbreak has hit the housing sector, a recent poll of our members reveals that 96% reported that virus mitigation efforts were hurting buyer traffic. disrupting residential construction and the overall economy, the need and demand for housing remains acute.

COVID leads to sharp decline in housing starts

Reflecting the growing impact of the COVID-19 pandemic, total housing starts decreased 22.3% in March from a downwardly revised February reading to a seasonally adjusted annual rate of 1.22 million units, according to a report from the U.S. Housing and Urban Development and Commerce Department. Meanwhile, overall permits declined 6.8% to 1.35 million.

The March reading of 1.22 million starts is the number of housing units builders would begin if they kept this pace for the next 12 months. Within this overall number, single-family starts decreased 17.5% to an 856,000 seasonally adjusted annual rate. The multifamily sector, which includes apartment buildings and condos, decreased 31.7% to a 360,000 pace.

It is worth noting that there are currently 534,000 single-family homes currently under construction and 684,000 apartments.

HBACV continues to keep our industry essential, safe

The HBACV office remains open and continues to update members and provide materials regarding workplace safety and processes. We are also maintaining weekly contact with local Building Inspections/Permits offices to gather and distribute information on the ongoing changes of office procedures and processes. A specific email to builder members is sent out regularly about this.

Several HBACV members participated in the April 16th Stand Down / Worksite Safety event, taking time to review best practices to manage work safety at the job site, including safe distancing, crew transport and best hygiene/cleanliness

practices. Workers on home building sites should follow guidance from health officials. This includes maintaining a distance of no less than six feet with others at all times, limiting to 10 the number of workers on a job site, ensuring the proper sanitation of common surfaces, and not directly sharing equipment.

It is imperative that our members continue to follow the COVID-19 safety guidelines so we continue to maintain an essential business designation. States that did not receive this "essential" designation (New York, Massachusetts., Michigan, Washington.) are struggling in ways we are not.

Job Site Safety Info Available from NAHB, HBAV and HBACV

Your local, state and national associations have developed packets in both <u>English</u> and <u>Spanish</u> to help builders maintain the COVID-19 Job Site Safety Standard. he packet includes three easy steps to help you:

Step 1: Contact the appropriate association level and request the resouces materials. Then review the resources in the packet and any guidance from local governments or health officials that may be relevant.

- **Step 2:** Apply these practices and shares the COVID-19 Prevention and Work Practice Controls with your employees. Please strictly enforce social distancing guidelines. If you hold an employees' meeting have everyone stand at least six feet apart and do not conduct the meeting with groups larger than 10.
- **Step 3:** Continuously ensure workers and subcontractors who are on the job site follow social distancing and other coronavirus infection prevention measures.

New Updated Guidelines for HBACV Members, Real Estate Professionals Regarding COVID-19

The Home Builders Association of Virginia and the Virginia REALTORS ® are strongly recommending that members refrain from holding "traditional" in-person open houses for the foreseeable future.

Instead, each is urging members to transition to "by-appointment only" tours of model homes and properties also asking that appointments be staggered to allow staff time to sanitize the home prior to the next scheduled tour. Our associations are also advising our members to implement extended sanitation procedures at the beginning and end of the business day. Virtual and/or video tours are also encouraged.

The Virginia Department of Health has also issued new guidance, which can be found here.

While this may cause disruptions to your day-to-day business operations, given the severity of this emergency and your ability to proactively minimize the risk of transmission and community spread, these measures are prudent at this time.

Real estate professionals who conduct open house appointments, including builders who provide access to spec or model houses, are advised to follow best practices outlined in the VDH Guidelines on Open Houses, Model Homes and In-Office appointments.

If you do have in-person showings please follow these guidelines.

- 1. Limit interior access to no more than 10 persons and require social distancing protocols the six-foot rule.
- 2. Have all individuals who enter immediately wash their hands or use hand sanitizer
- 3. Have lots of extra pens and allow each person who signs in to use one pen that they then keep (or you sanitize before another person uses).
- 4. Ask people for their names and contact information that you write down or record on your electronic device
- 5. Open all doors and turn on lights prior to the start of the open house so people can walk around without touching door knobs and light switches.
- 6. Have paper towels near sinks if someone wants to turn a sink on/off
- 7. Have individuals wash hands or use hand sanitizer upon leaving

Remember, these are the minimum standards. Doing more, helps more.

10-POINT PLAN FOR BUILDING A SAFER JOB SITE

Hand hygiene

Wash with soap and water and sanitize when you can, especially after using common restrooms and when either entering or leaving a home site. Use the hand sanitizer provided in portable restrooms.

Stay off your face

The easiest way to catch germs is by touching your face, so train yourself not to.

Communicate

if you have any questions or concerns, please call your building partner's foreman

Sanitize as you go

If available, use sanitizers or other cleaning materials to keep your tools and your work product (countertops, sinks, faucets, wall and floor tiles) clean at least once per day. Do not leave the home until cleaning up after your work.

Keep your smartphone

You'd be surprised how many germs your phone accumulates; get in the practice of sanitizing it daily.

Let it go

Until the Coronavirus is behind us, stay away from shaking hands, or doing fist & elbow bumps.

Be considerate

Help prevent the spread of germs: stay home if you are sick.

Rely on the above 9 steps, be informed, and please do your part to keep yourself and your work environment healthy and safe.
